Salam Investasi

IHSG naik sebesar +0,05% (+1,82% MoM; +6,49% YTD) ke level 7.744,52. Pendorong laju indeks disebabkan oleh sektor kesehatan (+2,29%) dan sektor properti & real estate (+2,01%). Sedangkan dalam level saham, pendorong bobot indeks disebabkan oleh BREN (+4,66%), GOTO (+6,06%) dan TPIA (+2,23%). Investor asing tercatat melakukan net sell sebesar Rp2,27tn (Rp 36,72tn Mtd; Rp 54,11tn Ytd). Yield obligasi pemerintah 10 tahun naik sebesar 2,40bps menjadi 6,46% (-16,90bps Mtd; -1,60bps Ytd). Kurs Spot Rupiah terdepresiasi sebesar 0,44% di level 15.166/USD.
